**1.0** TPCL is developing 50 MWac Ground Mounted Solar Power Project ("Project") in Sampoore Trincomalee, Sri Lanka. TPCL invites **online bids** on **Single Stage Two Envelope bidding basis (i.e. Envelope-I: Techno-Commercial bid & Envelope-II: Price bid)** followed by an e-Reverse Auction (from eligible bidders), at e-tender portal <https://www.electronic tender.global/>, for aforesaid package, as per the scope of work.

**2.0 BRIEF SCOPE OF WORK:**

Design, engineering, manufacturing, supply, packing and forwarding, transportation, unloading storage, installation, testing and commissioning of 50 MWac Solar Photovoltaic plant including supply of Solar PV modules and BESS system of 20 MW/ 20 MWh. Comprehensive O&M of SPV Plant for a period of five (05) years from the date of commissioning of full project capacity. Detailed scope of work, specification, and terms & conditions are given in the bidding documents, available at the e-tender portal.
