## ECONOMIC DATA OF SRI LANKA & GERMANY

#### Inflation in Sri Lanka

On-year-on-year basis, National Consumer Price Index (NCPI) (2021=100) based headline inflation decelerated to 1.1 per cent in August 2024 from 2.5 per cent in July 2024. Food inflation recorded 2.3 per cent, while Non-Food inflation recorded 0.2 per cent. Further, the NCPI based core inflation decelerated to 2.3 per cent in August 2024 from 3.0 per cent in July 2024.

#### **Inflation in Germany**

The annual inflation rate in Germany fell to 1.6% in September 2024, below forecasts of 1.7%, down from 1.9% in August, preliminary estimates showed. It was the lowest since February 2021.




#### Sri Lanka Trade Statistics


As per the provisional data released by the Sri Lanka Customs, the merchandise export performance in August 2024 amounted to US\$ 1,165.4 million, recorded an increase of 4.18 % compared to the month of August 2023. This was mainly due to the increase in earnings from export of Apparel & Textiles, Tea, Rubber based products, Coconut based products and Spices & Concentrates.

The estimated value of services exports for the month of August 2024 was US\$ 318.77 Million, increasing 6.49 % over the corresponding period of 2023.

#### **Germany Trade Statistics**

On a calendar and seasonally adjusted basis, German exports to countries outside the European Union (third countries) were down 1.1% in August 2024 compared with July 2024. According to provisional data of the Federal Statistical Office (Destatis), Germany exported goods to the value of 58.5 billion euros to these countries in August 2024, after seasonal and calendar adjustment.

#### **EU Trade Statistics**

Exports to the European Union (EU) which accounts for 24% of Sri Lanka's exports, decreased by 1.64 % y-o-y in August 2024. In parallel, exports to EU decreased by 0.75 % during the cumulative period of January to August 2024.

Exports to the top five EU markets were recorded as; Germany US\$ 430.01 Mn (increased by 8.51 %), Italy US\$ 395.69 Mn (decreased by 11.05%), Netherlands US\$ 253.28 Mn (increased by 12.59%), France US\$ 178.49 Mn. (decreased 21.29 %) and Belgium US\$ 154.58 Mn (increased by 2.53%) during the cumulative period of January to August 2024 in comparison to the corresponding period in 2023.

#### **Apparel and Textile Exports**

Export earnings from Apparel & Textile increased by 17.51 % y-o-y to US \$ 511.13 Mn in August 2024 compared to August 2023. Additionally, exports of Apparel & Textile to USA increased by 22.56 % in August 2024 compared to August 2023.



#### **Coconut-based Exports**

On monthly analysis, export earnings of Coconut based products increased by 38.3 % in August 2024 compared to August 2023. Moreover, export earnings of Coconut kernel products, Coconut fiber products and Coconut shell products increased by 50.15 %, 29.42 % and 18.36 % respectively in August 2024 compared to August 2023.



#### **Rubber-based Exports**

Export earnings from Rubber & Rubber finished products increased by 11.52 % to US\$ 679.43 Mn in January – August 2024 compared to the same period in 2023 attributed to increased exports of Industrial & Surgical Gloves of Rubber (17.08 %) and Pneumatic & Retreated Rubber Tyres & Tubes (10.56 %).



#### **Tea Exports**

Export earnings from tea, which made up 12% of merchandise exports, increased by 9.11 % y-o-y to US\$ 130.54 Mn in August 2024 compared to August 2023. This increase is mainly due to the positive performance in the export of Bulk Tea (5.78%) and Tea packets (11.43%).

Additionally, Tea exports to Iraq and Iran markets, increased by 13.35 % and 114.41 % respectively.

## TOURISM NEWS IN SRI LANKA

#### **Tourist Arrivals in Sri Lanka**

In August, Sri Lanka welcomed 164,609 tourists, reflecting a 12.3% decline compared to July but showing a 20.7% increase compared to August 2023. The total tourist arrivals by the end of August reached 1,362,688, highlighting a steady recovery in the tourism sector. The month-over-month decline could be attributed to seasonal fluctuations, as August often sees reduced travel due to the end of summer vacations in key source markets.



However, the year-on-year growth of 20.7% indicates a positive trend, driven by ongoing efforts to attract more visitors compared to the previous year, when numbers were likely impacted by lingering effects of the pandemic or economic challenges. Despite the monthly variations, the cumulative total emphasizes the resilience and gradual recovery of Sri Lanka's tourism industry, although factors like seasonality and economic conditions in source countries may continue to influence arrival numbers.

#### **German Tourist Arrivals in Sri Lanka**

In August, Sri Lanka's primary source markets were India, the United Kingdom, China, Germany, and Italy with notable increases in visitors from these countries driving the growth of the tourism sector.



# GERMANY AIMS TO BE WORLD LEADER IN QUANTUM TECHNOLOGIES, SAYS SCHOLZ



German Chancellor Olaf Scholz vowed to support the development of quantum technologies, saying at the opening of an IBM data centre on Tuesday that investment in the sector was crucial for the future of Europe's biggest economy.

"Our goal is clear: to be global leader in quantum technologies," said Scholz, adding Germany had invested 2 billion euros (\$2.22 billion) on quantum technology since 2020.

"This is the basis of our economic success and prosperity," he said at the opening of IBM's Quantum European Data Center in Ehningen, a roughly 290 million euro investment. The centre will allow users in Europe and elsewhere to access services for cloud-based quantum computing research.

Quantum computers could operate millions of times faster than advanced supercomputers. So far, the United States and China have led the technology.

Other projects in Germany include the joint development of quantum processors by Infineon and eleQtron GmbH.

Scholz said Germany was focused on semiconductors, AI, pharmaceuticals and bio- and climate technologies.

"These are the areas we need to lead," said Scholz, adding it was vital Europe pushes ahead with semiconductor production despite a delay in a planned investment by U.S. chipmaker Intel in the city of Magdeburg.


